DUAL Q is an effective sanitizer at 150 ppm active quat for use on hard, non-porous, food contact surfaces in 400 ppm hard water against: *Escherichia coli* [ATCC11299] and *Staphylococcus aureus* [ATCC6538]. DUAL Q can be diluted for use with a mop and bucket, trigger sprayers, sponge or by soaking. It can be used on hard, non-porous, food contact surfaces in a concentration of 0.25 oz. - 0.68 oz. per gallon [150 – 400 ppm active].

Use DUAL Q as a sanitizer on dishes, glassware, and utensils. Use DUAL Q as a sanitizer for all hard, non-porous surfaces not always requiring a rinse in official establishments operating under the Federal meat, poultry, shell egg grading and egg products inspection programs.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Prepare a fresh solution daily or more often if the use solution becomes visibly diluted or soiled. This product is not for use on medical device surfaces.

Use DUAL Q to sanitize hard, non-porous surfaces of food processing equipment, dairy equipment, food utensils, dishes, silverware, glasses, sink tops, countertops, refrigerated storage areas and display equipment and other hard non-porous surfaces. Use Dual Q to sanitize Food Processing Equipment, utensils, and other food contact articles regulated by 40 CFR § 180.940(a) in a three compartment sink.

Use DUAL Q to sanitize hard, non-porous surfaces of non-food contact surfaces.
