Pine Cleaner Concentrate is a synthetic, low-foaming, neutral detergent formulated for safe and effective use on all types of floors and general cleaning applications. Low-foaming action makes it especially useful with automatic scrubbing equipment and wet-vacs. Neutral pH makes it ideal for use on floors which have wax or acrylic finishes. Pine Cleaner Concentrate is biodegradable, non-toxic, non-corrosive and will not build up or scale equipment. It is non-flammable, has no butyl or petroleum solvents and has a fresh scent.

## DIRECTIONS FOR USE

### Directions for Use:

Dilutions may vary according to the severity of the soil, type of surface to be cleaned, cleaning method used and other factors. The following dilutions are given as a guideline only. The user should experiment with various dilutions to find the one most effective and economical.

**LIGHT SOIL:** For daily cleanings, damp mopping, auto scrubbing and use on finished floors, use 2 ounces per gallon of water.

**MEDIUM SOIL:** For general cleaning, damp mopping, and use on low maintenance floors, use 4 ounces per gallon of water.

**HEAVY SOIL:** For heavy cleanings, scrub and re-coat procedures, and heavy scrubbing of non-finished floors, use 8-12 ounces per gallon of water.

Dilutions of more than 2-4 ounces may require the use of a defoamer in the recovery tanks of automatic and wet-vacs.

## GENERAL PRODUCT INFORMATION

**Description:** Neutral Pine Cleaner Concentrate

**Safety:** Corrosive. Keep product stored in original container, in an upright position, with container tightly closed. Wear protective clothing, gloves, and eye and face protection. If swallowed, rinse mouth - Do Not induce vomiting. If on skin, wash with water - remove contaminated clothing.
